MCBG skyrockets to Rs421.00

Traded (MVT) for the day amounts to Rs23.6m, with volume traded of I.3m.

The SEMDEX closes the session at 2,233.67 (+1.1%). Market Value Investments: CAUDAN Rs0.44 (+12.8%), CIEL Rs8.08 (+1.0%), ENL Rs21.05 (+0.2%), MDIT Rs1.84 (+8.2%) PAD Rs99.00 (+3.1%). UTDL Rs59.50 (+0.9%).

Foreign investors are net buyers with Foreign Investor Purchases (FIP) of Rs5.9m, compared to Foreign Investor Sales (FIS) of Rs0.8m.

Leisure: NMH closes higher at Rs13.00 (+2.4%), LUX adds +1.8% to close at Rs58.00, **SUN** jumps to Rs48.00 (+3.8%).
