SBMH reverses its gains

Semdex 2,108.38 Sem-10 395.87 Demex 238.22

The **SEMDEX** inches up to 2,108.38 (+0.02%). Market Value Traded (MVT) for the day amounts to Rs30.9m, with volume traded of 0.7m.

Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs I.8m, compared to Foreign Investor Sales (FIS) of Rs 8.0m.

SBMH reverses yesterday's gains as it declines by -0.6% to close today's session at Rs4.70. Value traded for the day amounts to Property: BLL rises to Rs0.48 (+4.4%). Rs I.9m, accounting for 6.0% of MVT. The stock is up by +3.3% yearto-date, and its current dividend yield stands at 8.5%.

Finance: MCBG Pref adds +1.5% to close at Rs10.30.


Commerce: SHEL inches up to Rs350.00 (+0.3%).
