### **MCBG** leads market activity

The **SEMDEX** falls by 1.77 points to close at 2,106.60 (-0.1%). Market Value Traded (MVT) for the day amounts to Rs28.4m, with 3.3% to close at Rs22.00. volume traded of 0.6m.

Foreign investors are net sellers with Foreign Investor Purchases POLICY Rs3.25 (-0.9%). (FIP) of Rs0.8m, compared to Foreign Investor Sales (FIS) of Rs5.8m.

MCBG closes unchanged at Rs382.50. Value traded for the day amounts to Rs18.7m, accounting for 65.7% of MVT. FIS sums to Rs5.6m. MCBG's market capitalization currently stands at Rs97.7bn, (-3.8%). TROPICAL (Ord) inches up to Rs2.76 (+0.4%). with a year-to-date return of +18.1%.
