SBMH retreats to Rs4.70

2,105.24 Sem-10 395.42 **Demex** 238.23 Semdex

Traded (MVT) for the day amounts to Rs31.4m, with volume traded flat at Rs22.00.

Foreign investors are net buyers with Foreign Investor Purchases (FIP) of Rs2.9m, compared to Foreign Investor Sales (FIS) of Rs0.3m.

SBMH retreats to Rs4.70 (-0.2%). Value traded for the day amounts to Rs5.6m, accounting for 17.8% of MVT. FIP sums up to Rs1.3m. The stock is currently up by 3.3% year-to-date, with a dividend yield of 8.5%.

Finance: MCBG closes unchanged at Rs382.50, with value traded for the day amounting to Rs16.5m.

Industry: MCFI jumps to Rs9.48 (+11.5%), MOROIL advances further to Rs16.40 (+3.1%).
