Hotel stocks close in the green territory

The **SEMDEX** breaks its losing streak to close at 2,152.59 (+0.3%). Market Value Traded (MVT) for the day amounts to Rs27.5m, with volume traded of 1.3m.

Leisure: LOTO jumps by +6.1% to close at Rs5.88.

Investments: MSE declines to Rs55.50 (-0.9%).

Rs2.4m compared to Foreign Investor Purchases (FIP) of Rs0.9m.

Foreign investors are net sellers with Foreign Investor Sales (FIS) of **Property: ASCENCIA** edges lower to Rs17.40 (-0.6%), **BLL** drops to Rs0.47 (-4.1%).



Commerce: IBL rises to Rs44.05 (+2.3%).

Industry: PBL inches up to Rs490.50 (+0.1%).
