CIM breaks above Rs10.00

The **SEMDEX** inches up to 2,162.22 (+0.3%). Market Value Traded **Leisure: NMH** falls to Rs I 0.40 (-0.5%). (MVT) for the day amounts to Rs8.2m, with volume traded of 1.0m.

Foreign investors are net sellers with Foreign Investor Sales (FIS) of falls to Rs1.16 (-1.7%), VELG drops to Rs18.50 (-1.6%). Rs0.5m compared to Foreign Investor Purchases (FIP) of Rs0.0008m.

On the DEMEX, CHSL closes lower at Rs19.50 (-1.3%), LAVA


