MCBG maintains momentum with 15th consecutive gain

The SEMDEX rises by 25.4 points to close at 2,259.11 (+1.1%). Industry: GAMMA closes lower at Rs30.30 (-0.7%). Market Value Traded (MVT) for the day amounts to Rs65.5m, with volume traded of 1.2m.

Foreign investors are net buyers with Foreign Investor Purchases (+0.5%). (FIP) of Rs44.2m, compared to Foreign Investor Sales (FIS) of Rs38.5m.

MCBG continues to break records as it extends its winning streak for the 15th consecutive session. The stock surges to Rs430.00 (+2.1%), with value traded for the day amounting to Rs46m. FIP amounts to Rs43.1m, compared to FIS of Rs38.3m.

Finance: SBMH gains +3.7% to close at Rs5.58, CIM moves up to Rs11.10 (+0.9%).

Information, Communication & Technology: EMTEL falls further to Rs19.95 (-0.3%).


