The **SEMDEX** advances to 2,362.85 (+0.3%). Market Value Traded (MVT) for the day amounts to Rs56.0m on a volume of 2.3m shares.

Foreigners are net sellers with foreign sales of Rs32.6m compared to foreign purchases of Rs32.1m.

MCBG inches up by +0.8% to close at Rs457.00. Value traded for the day amounts to Rs35.5m, accounting for 63.4% of total market turnover. At the current price, its market capitalization stands at Rs119.5bn.

Commerce: IBL closes lower at Rs30.10 (-0.3%)


Industry: GAMMA inches up to Rs31.30 (+0.3%).
