ICT: EMTL falls to Rs22.75 (-1.1%).

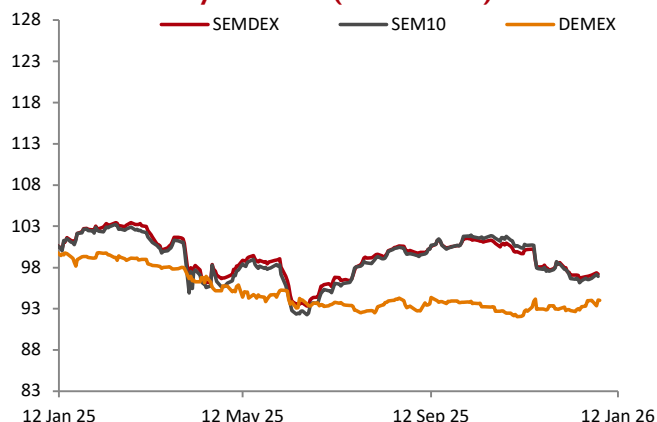
Commerce & Industry: IBL falls to Rs29.20 (-0.2%), **UBP** closes lower at Rs56.00 (-6.3%).
